**NOTIFICATION**

The following rules for open competitive examination to be conducted by Sikkim Public Service Commission (in short, Commission or SPSC) for appointment in the following posts under Technical Wing of the Sikkim Government Pharmacy College Service in Health and Family Welfare Department, Government of Sikkim, is prescribed as under, namely :-

1) Detail of Posts :-

- 2) The number of vacancies to be filled-up after the examination will be specified in the Notice to be issued by the Commission.
- 3) The examination will be conducted by the Commission according to syllabus and procedure as indicated in the Appendixes appended to these rules.
- 4) The date and place of examination will be fixed by the Commission.
- 5) The candidates must write answer in his/ her own handwriting. Under no circumstances will he/ she be allowed the help of a scribe to write the answers.
- 6) A candidate must pay fees as may be prescribed by the Commission.
- 7) The decision of the Commission as to the eligibility of a candidate for admission to the examination shall be final. Their admission at all stages of examination for which they are admitted by the Commission, will be purely provisional subject to their satisfying the prescribed eligibility conditions. If on verification at any time before or after the examination, it is found that they do not fulfill any of the eligibility conditions, their candidature for the examination will be cancelled by the Commission.
- 8) No candidate will be admitted to the Examination Hall unless he/ she hold a certificate of admission issued by the Commission. Their admission to all the stages of the examination will be purely provisional subject to satisfying the prescribed eligibility tests. Mere issuance of admission certificate to the candidates will not imply that his/ her candidature has been finally cleared by the Commission.
- 9) A candidate who is or has been declared by the Commission to be guilty or any attempt on his/ her part to obtain support his/ her candidature by any means shall render him/ her liable to be disqualified for admission to the competitive examination.
- 10) Mobile phones/ pagers or any other communication devices are not allowed inside the premises where the examination is being conducted. Infringement of these instructions shall entail appropriate actions including ban from taking the examination.
- 11) Candidate are advised in their own interest not to bring any of the banned items including mobiles/ phones/ pagers to the venue of the examination, as arrangement for safe keeping cannot be assured.
- 12) Candidates are advised not to bring any valuable/ costly items to the Examination Hall, as safe keeping of the same cannot be assured. The Commission will not be responsible for any loss in these regard.
- 13) The Commission shall have the discretion to fix the qualifying marks in any or all subjects in the written examination.
- 14) The form and manner of announcement of results of the examination shall be decided by the Commission. The Commission will not enter into any correspondence with any Candidate regarding results.
- 15) After the examination, name of the successful candidates will be arranged by the Commission in order of merit based on the marks awarded to each candidate. Candidates shall be considered for appointment to the available vacancies in the order in which their name appear in the merit list.

- 16) A candidate who is or has been declared by the Commission guilty of impersonation or of submitting false and fabricated documents which have been tampered with or of making statement which are incorrect or false or of suppressing material information or of attempting to use unfair means in the Examination Hall or otherwise, or resorting to any or other irregular or improper means for obtaining admission to the Examination Hall may, in addition to rendering himself liable to criminal procedures, be debarred : -
- a) by the Commission permanently or for specified period for admission to any examination or appearance at any of the interview held by the Commission for selection of candidates,
  - b) by the State Government from any employment under them.
- 17) Candidates, already in Government Service or in Government owned Undertaking or similar Organization, whether on permanent or temporary capacity or as a Work charged Employee, shall be required to submit their applications alongwith a No Objection Certificate from their Employer.
- 18) Success in the examination confers no right to appointment unless the Government is satisfied after such enquiry as may be considered necessary that a candidate having regard to his/ her character and antecedents is suitable in all respect for appointment.
- 19) A candidate must be in good health and free from any physical deficit likely to interfere with the discharge of his duties. A candidate who (after such medical examination as may be prescribed by the Competent Authorities) is found not to satisfy these requirement will not be appointed.
- 20) If a candidate's handwriting is not legible, a deduction may be made in the account from the total marks otherwise accruing to him/ her.
- 21) No travelling and daily allowance will be paid for the journey performed in connection with the examination, interview/ tests and medical examination. All other matters not specified or for which no provision has been made in these rules shall be regulated by rules and orders applicable to the service to which recruitments are being made.
- 22) The candidate must obtain the qualifying marks decided by the Commission in the written examination.
- 23) The Scheme and Pattern of Examination will be determined by the Commission.
- 24) The Commission or the Department (s) will entertain the applications for review or the RTI's correspondences only after the entire process of recruitment is completed.
- 25) The candidate on selection and during the period of probation/ apprenticeship/ training, pay shall be governed by the Notification number 489/ GEN/ DOP; Dated : 31<sup>st</sup> October, 2011.
- 26) Any further instruction/ corrigendum/ addendum shall be published by the Commission for information to all.
