Applications are invited from the eligible local candidates for filling up of 10 (ten) posts of Sub-inspector (Sikkim Police) in the PB-2 of Rs 9300-34800 plus Grade Pay of Rs 3800/- under Police Department, through Direct Recruitment. All applications are invited through **online mode** ([www.spscsm.gov.in](http://www.spscsm.gov.in))

**ELIGIBILITY CONDITIONS FOR APPEARING IN THE EXAMINATION FOR THE POST OF  
SUB-INSPECTOR IN SIKKIM POLICE:**

- 1. Minimum Educational Qualification:** : **Degree from a recognized University.**
- 2. Age** : *Should have attained the age of 18 yrs & should not have exceeded 25 years as on 28/02/2018.*  
*The maximum age limit is relaxable by 05 years in case of SC/ST/BL candidates, 04 years for OBC (Central list) candidates, 03 years for OBC (State List) candidates. In case of Police Department candidates under Government of Sikkim in regular establishment, the maximum age is relaxed upto 45 years as on 1<sup>st</sup> Aug.'2014.*
- 3. Other Qualifications** :
  - a). *Should be conversant with the customs and usages of Sikkim.*
  - b). *Should have knowledge of any of the State Languages, viz. Nepali, Sikkimese, Bhutia, Lepcha or Limbooo.*
  - c). *Should have valid local Employment Card.*

## **6. SCHEME OF EXAMINATION:**

Candidates are advised to refer to **APPENDIX – II** for Detailed Scheme and pattern of Examination for the Preliminary Examinations, Physical Endurance-cum-Physical Efficiency Test and the Optional Subjects for the Main Written Examination. Candidates will not be allowed to offer the following combination of Subjects for the Optional Subject in the Main Written Examination and other criteria as laid down under **APPENDIX – III**. The syllabus as enclosed in **APPENDIX – II & APPENDIX – III** can be downloaded from <http://spscskm.gov.in/>

7. The candidates are advised to apply online from our website <http://spscskm.gov.in/> on or before **30.04.2018** upto 12 midnight. Application submitted after **30.04.2018** will not be accepted by the software and SPSC will not be responsible for the same.

8. Candidate should go through the advertisement and **read the instructions provided on the web page carefully before applying online. Applications received through any other mode shall not be accepted and summarily rejected.**

9. Application fee amounting to ₹150/- only may be paid online through credit/debit card, Net Banking by Visa/Mastercard. The amount once deposited shall not be refunded or adjusted against any other purpose. Candidates belonging to **PWD Category are exempted from paying the fees.**

10. e-Admit Cards can be downloaded and printed by the eligible candidates after a Notice for the same will be published by the Commission in the official website i.e. <http://spscskm.gov.in/>

11. Candidates are directed to bring a Photo Identity proof like (Addhar Card, Voters Card, Driving Licence) alongwith valid e-Admit cards in the examination centre for proof of identity.

**12. Rejection list of candidates who do not qualify for the post as per the advertised criteria will be uploaded in the SPSC website on 08.05.2018 and if any of the rejected candidates have reservation on rejection of application, they should submit their grievances along with justification to the office of the Controller, SPSC w.e.f. 11/05/2018 to 19/05/2018.**

13. Those candidates who qualify in the written examination will be called for the scrutiny of documents before the conduct of viva-voce/interview in the ratio as fixed by the Commission. Short listed candidates are required to submit attested Photocopies of all relevant documents on the dates specified by the Commission.

14. No TA/DA is admissible for attending the examination/P.E.T./Interview.

15. Admission at all the stages of examination for which candidates are admitted by the Commission viz. Written Examination and Interview Test will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission without notice.

16. The Commission will not entertain any application on review or RTI/Correspondence till the entire process of recruitment is complete.


