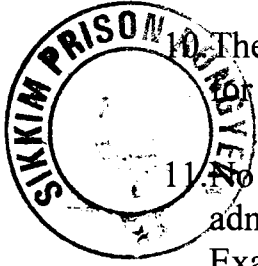
NOTIFICATION

The following rules for open competitive examination to be conducted by the Sikkim Public Service Commission for selection of candidates for appointment to the post of Sub-Jailer in Sikkim State Jail are notified hereunder, namely :

1. The examination being for recruitment to the post of Sub-Jailer under Sikkim State Jail, Government of Sikkim. The Recruitment for the post of Sub-Jailer in Sikkim State Jail is for male candidates only.
2. The number of vacancies to be filled-up after the examination will be specified in the Notice to be issued by the Sikkim Public Service Commission.
3. The examination including Physical Efficiency-cum-Physical Endurance Test (PET) will be conducted by the Sikkim Public Service Commission according to standards, marks and syllabus, as provided in the Appendix I, II & III to these rules.
4. Candidates from other departments already in Government service or in Government owned undertaking or similar organization, whether in permanent or temporary capacity or as work charged employee who intends to apply, shall be required to submit their applications along with the No Objection Certificate of their employer.
5. The Sikkim Public Service Commission will hold a preliminary qualifying examination prior to the conduct of PET and main written examination.
6. The date and place of examination will be fixed by the Sikkim Public Service Commission.
7. The Candidates must submit their applications and write answers in their own handwriting. Under no circumstances will he be allowed the help of a scribe to write the answers.
8. The Commission shall have discretion to fix qualifying marks in any or all subjects to the written examination.
9. The first stage – preliminary examination is meant to serve as a screening test only. The marks obtained in the preliminary examination by the candidate who is declared qualified for Physical Efficiency-cum-Physical Endurance Test and

subsequently to the Main Examination will not be counted for determining his final order of merit. Number of candidates who will be called after qualifying in screening test for Physical Efficiency-cum-Physical Endurance test will be approximately 12 to 15 times of the number of vacancies to be filled in order of merit in each category wise. The successful candidates qualifying in Physical Efficiency-cum-Physical Endurance Test will only be allowed to sit in the main examination.



10. The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the examination shall be final.

11. No candidate will be admitted to the examination unless he holds a certificate of admission issued by the Commission. Their admission to all the stages of the Examination will be purely PROVISIONAL subject to satisfying the prescribed eligibility condition. Mere issue of admission certificate to the candidate will not imply that his candidatures have been finally cleared by the Commission.

12. A candidate must pay fee as may be prescribed by the Commission.

13. Mobile phones/pagers or any other communication devices are not allowed inside the premises where the examination is being conducted. Infringement of these instructions shall entail appropriate actions including ban from taking the examination. Candidates are advised not to bring any valuable/costly items to the Examination Hall as safe keeping of the same cannot be assured. Commission will be not be responsible for any loss in these regard.

14. A candidate who is or has been declared by the Commission to be guilty or any attempt on his part to obtain support for his candidature by any means shall render himself to be disqualified for admission to the competitive examination.

15. After the PET and Main examination, the names of the successful candidates will be arranged by the Commission in the order of merit based on aggregate marks finally awarded to each candidate. Candidates shall be recommended by the Commission for appointment to the available vacancies in the order in which their names appear in the merit list of different categories.

16. The form and manner of announcement of results of the examination shall be decided at the discretion of the Commission. The Commission will not enter in any correspondence with any candidate regarding results. Candidates are also informed that the total marks, category wise cut off marks and answer keys of the Preliminary Examination, the marks of the physical efficiency test and total marks of the main examination will not be provided until the entire process of the Examination is over i.e. after the declaration of final result. No application in this regard will be entertained.

17. A candidate who is or has been declared by the Commission guilty of impersonation or of submitting false and fabricated documents which have been tempered with or making statements which are incorrect or false of suppressing material information or of using or of attempting to use unfair means in the examination hall or otherwise, resorting to any other irregular or improper means for obtaining admission to the examination may, in addition to rendering himself liable to be prosecuted, be debarred :

- a) By the Commission permanently or for specified period for admission to any examination or appearance at any of the interviews held by the Commission for selection of candidates.
- b) By the State Government from any employment under them.

18. Success in the examination confers no right to appointment unless Government is satisfied after such enquiry as may be considered necessary that a candidate having regard to his character and antecedents is suitable in all respect for appointment.

19. A candidate must be in good mental and bodily health and free from any physical defect likely to interfere with the discharge of his duties as an officer of the Jail service. A candidate who (after such medical examination as may be prescribed by the competent authority) is found not to satisfy these requirements will not be appointed.

20. If a candidate's handwriting is not easily legible, a deduction may be made in this account from the total marks otherwise accruing to him.

21. Credit will be given for good English including orderly, effective and exact expression combined with economy of words in all subjects of the examination and not only in subjects, which are especially devoted to English.

22. No travelling and daily allowance will be paid for the journey performed in connection with the examination (both Preliminary & Mains), physical endurance-cum-physical efficiency test and medical examination.

23. All other matters not specified or for which no provision has been made in these rules shall be regulated by rules and orders applicable to the Service to which recruitment is being made.


