- Bachelor of Medicine and Bachelor of Surgery Degree (MBBS) mark sheet & certificate.
- Post Graduate Degree in Clinical, Para-Clinical and Pre-Clinical subjects mark sheet & certificate.
- Rotatory internship of one year from a MCI recognized institution and registered with Medical Council of India or Medical Council of the State.
- Certificate of Identification.
- Renewed Unmarried Certificate (for female candidates) OR in case of married female candidates (husbands C.O.I).
- Local valid employment card.
- NOC in case of government servant.

Admission to all the stages of examination for which candidates are admitted by the Commission viz: Written Examination and Viva-Voce as the case may be will be purely provisional subject to their satisfying the prescribed eligibility conditions. If on verification at any point of time before or after the Written Examination and Viva-Voce, it is found that the candidates do not fulfill any of the eligibility conditions, their candidature for the examination/post will be cancelled by the Commission.
